Regulations for the Request of Reproductions for Private Use

Terms of Use

With regard to requesting reproduction of material included in the collections owned by the Library of the Pontifical Gregorian University, I hereby declare that I acknowledge and accept the following conditions:

1. request approval: the Library of the Pontifical Gregorian University has the right to follow-up on requests within the limits of its technical abilities and to take into account the state of preservation of requested material;
2. usage limits: material will be used only for private study purposes and only by the Requestor, and it will remain at all times under his personal custody and control;
3. involvement of third parties: should other people be involved in activities dealing with the material hereby discussed, the Requestor guarantees compliance of these individuals with the present conditions;
4. Ban on modifications and other usage restrictions: the Requestor shall not use reproduced material or parts of it, to create new material or images on which copyright might be claimed; he/she shall not publish reproduced material in any form or media, publicly display it, or distribute it for educational purposes, use it for conferences, make copies of it, distribute it or sell it in any possible way, store it or save it on computer networks or internet websites;
5. usage for other purposes: usage of reproductions for purposes other than private and for personal study involves a specific authorization from the Library, which may or may not be granted, and therefore is at its sole discretion. However, if granted, it will result in payment of additional costs and it will require a written license, signed by both the Requestor and the Library;
6. copyright compliance: the Requestor will consider reproduced material as protected by copyright owned by the Library, by which follows that he/she will duly comply with all legal and regulatory provisions, both national and international, issued for protection of copyright and other intellectual property rights;
7. unauthorized use of library materials: the Requestor declares and guarantees that he/she has never, without previous authorization from the Library, reproduced, published, reprinted, transferred, copied, distributed or, in any other way, used any of the Library's collections or their reproductions, and undertakes not to do so in the future, acknowledging and accepting that this behaviour will be a hindrance to further authorization of usage of the Library's material;
8. violations: violation of any of these conditions will cause immediate, major, and potentially irreparable damage to the Library, its collections, together with its rights and interests. The Requestor accepts and acknowledges that the Library will be entitled to request precautionary or emergency measures in order to redress or prevent violations or potential violation of these conditions. The Requestor also acknowledges that the enactment of such measures, might compromise his/her ability to use works that contain or incorporate the Library's material; thus, he/she renounces to raise any kind of objection, based on these premises;
9. transparency: all information provided by the Requestor about the present request, or in any case related to it, are true and accurate.
